Articles of Incorporation

of

The undersigned, for the purpose of forming a corporation under the *Florida General Corporation Act*, Chapter 607 *Florida Statutes*, do hereby adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is *RINEHART PRESSURE CLEANING, Inc.*

ARTICLE II. EFFECTIVE DATE & DURATION

The effective date of the incorporation shall be November 1, 2003, or as soon after that date as the Articles of Incorporation are filed in the office of the Secretary of State. The period of the corporation's duration shall be perpetual or until dissolved on a vote of the shareholders.

ARTICLE III. PURPOSE

The corporation is organized for the following purposes:

To engage in the business of pressure washing and cleaning as a business for profit and any other business permitted under applicable laws, whether related to the original purpose or not.

ARTICLE IV. CAPITALIZATION

The amount of capital with which the corporation will begin its business is not less than Five Thousand Dollars (\$5,000.00).

ARTICLE V. PRINCIPAL OFFICE AND REGISTERED AGENT

The address of the corporation's principal office is 390 SE 28th Loop, Melrose, FL 32666. The name of the initial registered agent of the corporation is Brian S. Rinehart, 390 SE 28th Loop, Melrose, FL 32666.

ARTICLE VI. CORPORATE POWERS

The corporation shall have all the rights and powers now or hereafter conferred on corporations by the laws of the State of Florida, including, but not limited to, the following:

A. To engage in the business of pressure washing and cleaning and any other business for profit.

B. To own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation, including registration of and operation of the business under one or more fictitious names.

C. To invest its funds in inventory, real estate, mortgages, stocks, bonds or any other type of investments.

D. To own real or personal property necessary for the rendering of the business of *RINEHART PRESSURE CLEANING, Inc.*

E. The above are in addition the general powers granted under Florida Statutes and not in limitation thereof.

ARTICLE VII. SHARES ISSUED

The aggregate number of shares which the corporation is authorized to issue is 1000. Such shares shall be of a single class, and shall be \$1.00 per share par value.

ARTICLE VIII. MANAGEMENT - DIRECTORS OR STOCKHOLDERS

RINEHART PRESSURE CLEANING, Inc., may be managed by a Board of Directors or by the stockholders, as the stockholders may so choose at any time, as set forth in the bylaws.




