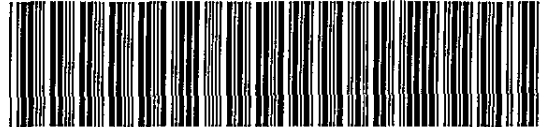

Articles of Incorporation of

- SECOND: The period of its duration is Perpetual

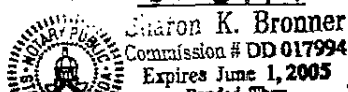
