

ARTICLES OF INCORPORATION
OF
K & M CABINETRY, INC.

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I, NAME

The name of the corporation shall be K & M CABINETRY, INC.

ARTICLE II, NATURE OF BUSINESS
