The power to adopt, alter, amend or repeal By-Laws is vested in the Board of Directors and the shareholders.

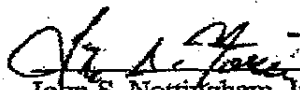
ARTICLE XII. INDEMNIFICATION

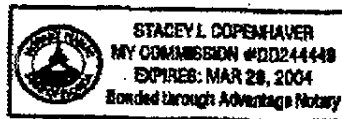

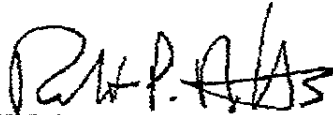
