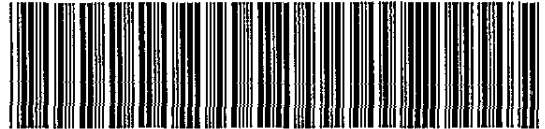

FOR


