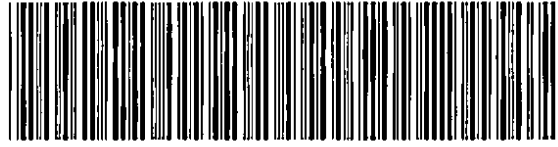

ARTICLE I

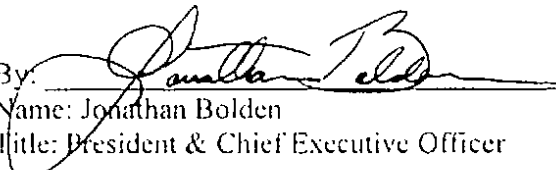
The name of the corporation is BCAM JAX, Inc.
