

#### **ARTICLE I - NAME**

The name of this corporation is CAMERON'S CUSTOM TRIM CARPENTRY, INC.

#### **ARTICLE II - DURATION**

This corporation shall exist perpetually.

#### **ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business.
