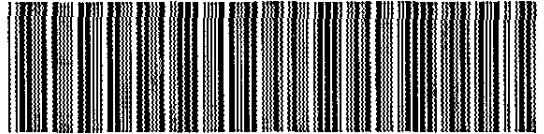

ARTICLES OF INCORPORATION

## ARTICLE X. AMENDMENT

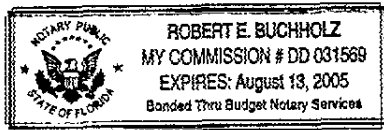


