ARTICLES OF INCORPORATION

OF

The undersigned incorporator, ROBERT C. SANSING, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, *Florida Statutes*.

ARTICLE I - NAME

The name of this corporation shall be:

ARTICLE II - PRINCIPAL OFFICE
