

ARTICLES OF INCORPORATION
OF
GIL'S AUTOBODY CORPORATION

The undersigned, NORMA DEL VALLE-ORTIZ, acknowledge and files in the Office of the Secretary of State of the State of Florida for the purpose of forming a corporation for profit, in accordance with the laws of the State of Florida, these Articles of Incorporation, as by law provided.

ARTICLE I

NAME:

It is expressly declared and provided that the corporation, to carry on its business, or for the purpose of publishing any of the objects here in above mentioned shall have the power to make and perform contracts of any kind and description to do any and all other acts and things, and to exercise any and all other power, either as principal, agent or broker conferred by the laws of the State of Florida upon corporations formed under the laws of said state and which now or here after may authorized by law:

ARTICLE IV

SHARES

The authorized capital stock of this corporation shall consist of: One Thousand (1,000) shares of common stock, One dollars (\$1.00) par value.

ARTICLE V

EXISTENCE

The corporation shall have perpetual existence.

(e) All shareholders of the corporation shall be vested with full preemptive rights.
