# ARTICLES OF INCORPORATION OF FIRST FLORIDA REAL ESTATE SPECIALISTS, INC.

THE UNDERSIGNED, acting as sole incorporator of FIRST FLORIDA REAL ESTATE SPECIALISTS, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:


