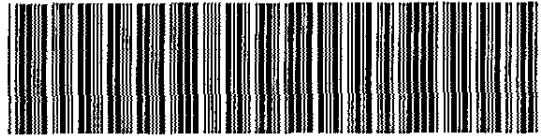

The name of this corporation is "Teddy Bears Cleaning, Inc.". The principal location of the corporation is 257 Morningside Avenue, Daytona Beach, Florida 32118.

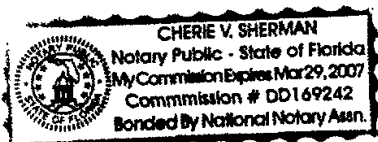

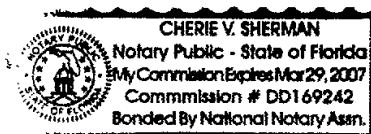
