Article I - Name

The name of this corporation is KEITH LOZEAU, INC. The mailing address/principal office of the corporation is: 1424 Golf Avenue, Ormond Beach, FL 32174.

Article II - Duration

This corporation shall have perpetual existence.

Article III - Purposes
