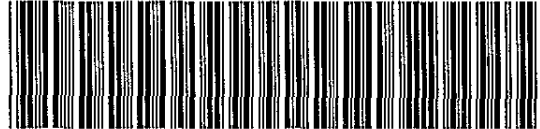

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby binds himself to form a corporation under the laws of the state of Florida.

1. CORPORATE NAME. The name of this corporation is JTL CORP. OF PUTNAM COUNTY
2. ADDRESS. The Post Office address of the principal office of this corporation in the state of Florida is : 221 Tanner Road, Florahome, Florida 32635.
3. TERM. This corporation shall have perpetual existence.
4. CORPORATE PURPOSE. To include the transaction of any or all lawful business for which corporations may be incorporated under the Florida General Corporation Act.
5. CAPITAL STOCK. The number of shares that may be issued by the corporation is 100 shares of Common Stock of the Par Value of Ten Dollars per share.
6. INITIAL CAPITAL. The amount of the capital with which this corporation will begin business is one thousand dollars.

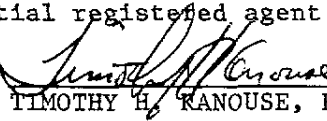

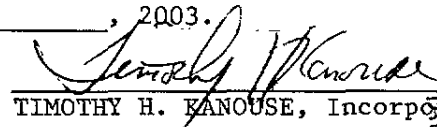
