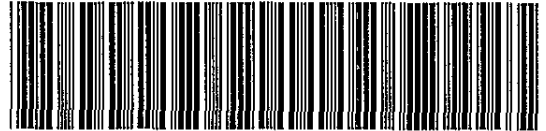



ARTICLES OF INCORPORATION OF
TOTAL ASSOCIATED DISTRIBUTORS, INC.
ARTICLE I.

CORPORATE NAME

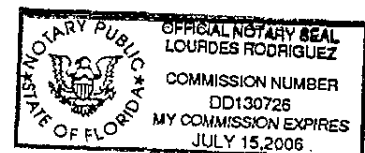
