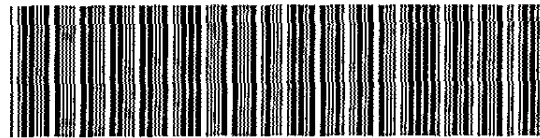


#### **ARTICLE XI**


