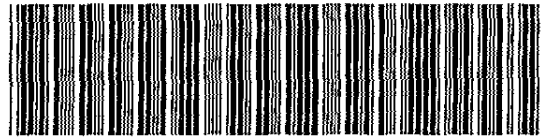

ARTICLE IX - BYLAWS


