The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I Name

The name the Corporation shall be ALL OCCASION BUSSING, INC.

ARTICLE II Principal Office and Address


