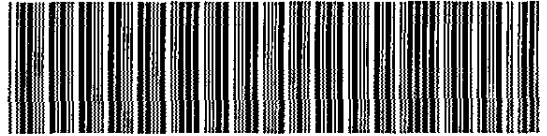

**ARTICLE I – NAME & LOCATION**

## **ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT**




