ARTICLES OF INCORPORATION of LUTHER CASTLE DRYWALL SERVICES, INC

ARTICLE I - NAME AND LOCATION OF PRINCIPAL OFFICES

The name of this corporation is: LUTHER CASTLE DRYWALL SERVICES, INC, with initial principal offices located at 3582 Eunice Road, Jacksonville Beach, Florida 32250.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of filing of these Articles with the Department of State.
