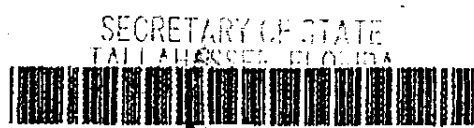


Attached please find a check for \$ 150.00 to pay for the 2004 Annual Report of Florida Profit Corp. Document number P 03000116201.
