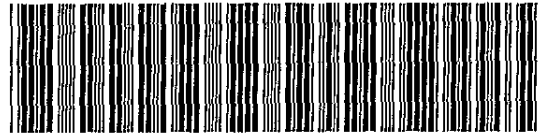

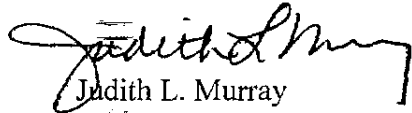

In compliance with the requirements of Chapter 607 of the Florida Statutes, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("the Corporation") is Johnson Plumbing, Inc.

ARTICLE II

The existence of the Corporation shall begin on November 1, 2003.

ARTICLE III

The street address of the principal office of the Corporation is 6318 4th Avenue, Keystone Heights, Florida 32656, and the mailing address of the Corporation is Post Office Box 1548, Keystone Heights, Florida 32656.

ARTICLE IV

The Corporation is authorized to issue Fifty Thousand (50,000) shares of common stock having a par value of One Cent (\$.01) per share.

ARTICLE V

The street address of the Corporation's initial registered office is 160 Magnolia Avenue, Keystone Heights, Florida 32656. The initial registered agent for the Corporation at that address is James J. Taylor Jr.

ARTICLE VI
