ARTICLE I: NAME

however, that there shall be no indemnification against gross negligence or willful misconduct.

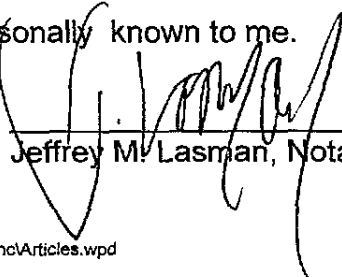

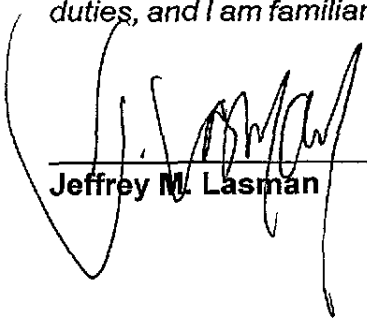
