

ARTICLES OF INCORPORATION

OF

BRUCE BISHOP TRIM, INC.

Pursuant to the provisions of section 607.1006, Florida Statutes, this corporation adopts the following Articles of Amendments to its Articles of Incorporation:

Article 7 of the Articles of Incorporation of BRUCE BISHOP TRIM, INC. states: FIRST:
