

ARTICLE I - NAME

The name of this Corporation shall be SOCIETY PRODUCTIONS INTERNATIONAL, INC.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities and/or business permitted under the Laws of The United States and of The State of Florida.
