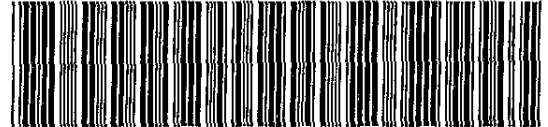

**ARTICLE I - NAME**

**The name of this Corporation shall be FAST FREDDY RECORDS, INC.**

**ARTICLE II - DURATION**

**The Corporation shall have a perpetual existence.**

**ARTICLE III - PURPOSE**

**The purpose of this Corporation is to engage in any activities and/or business permitted under the Laws of The United States and of The State of Florida.**

**ARTICLE IV - CAPITAL STOCK**

**The maximum number of shares which this Corporation is authorized to have outstanding, at any time, is One Hundred Million (100,000,000) shares of Common Stock having a Par Value of \$0.001 per share. The maximum number of Preferred Stock shares which this Corporation is authorized, in addition to the Common Stock shares, is Twenty Million (20,000,000) shares of Preferred Stock with a Par Value of One (\$1.00) Dollar per share, bearing a Ten (10%) Percent Interest for a period not to exceed Two (2) Years, and convertible at any time, at the option of the Corporation, to the Common Stock of the Corporation on a One to One basis. The Corporation, at its option, may issue either convertible Class A Warrants, and/or Class B Warrants with a defined conversion rate and conversion time, to be determined by the Corporation, with a One to One conversion basis to the Common Stock of the Corporation, and as determined by the Corporation.**

**ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT**

**The initial registered office of this Corporation shall be at 3550 Biscayne Boulevard, Suite #201, Miami, Florida 33137-3833, Telephone: (305) 573-6065, and the initial registered agent shall be MATTHEW FREDERICKS, who upon having**

accepted this designation, agrees to comply with the provisions of Section 48.091, Florida Statutes, as amended from time to time, with respect to keeping an office open for service of process. The principal office address of this Corporation shall be 3550 Biscayne Boulevard, Suite #201, Miami Florida 33137-3833.

#### ARTICLE VI - INITIAL BOARD OF DIRECTORS

The initial Board of Directors shall consist of Three (3) Members. The number of Directors may be increased or decreased from time to time by the vote of the stockholders, but in no case shall the number of Directors be less than (1) nor more than eleven (11). 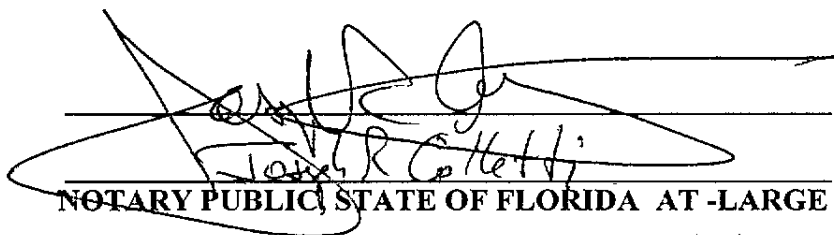

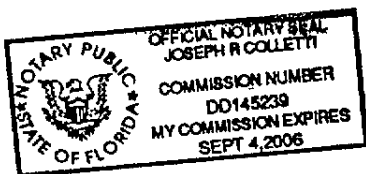
