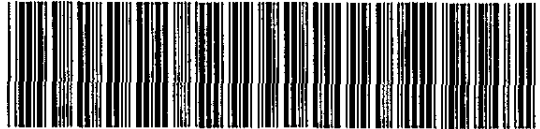



The adoption date of these Articles of Amendment shall be October 9, 2003.


