ARTICLES OF INCORPORATION OF JIM MILTENBERGER, INC.

The undersigned, acting as Incorporator of a Corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such Corporation:

ARTICLE I

The name of the Corporation is Jim Miltenberger, Inc.
