

**ARTICLE I**

The name of this corporation is MBR Information Technology, Inc.

**ARTICLE II**

The purpose or purposes for which this corporation is organized is for the purpose of transacting any and all lawful business.

**ARTICLE III**



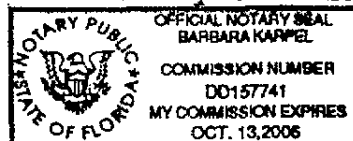
