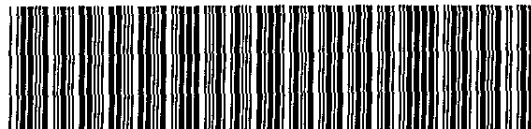

ARTICLE I. NAME

The name of this corporation is Steve Pospichal Enterprises, INC.

ARTICLE II. DURATION



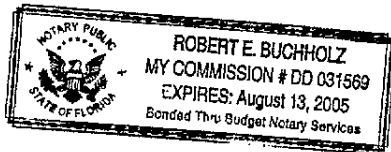
