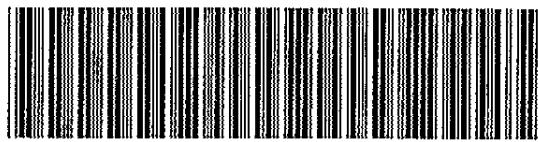

# ARTICLES OF INCORPORATION OF KVM SECURITY, INC

The undersigned, as incorporator of a corporation under the Florida General Corporation Act, Adopts the following Articles of Incorporation for such Corporation.

- I. The name of the Corporation is **KVM SECURITY, INC.**
- II. The principal office is located at 810 S.E. 8<sup>th</sup> Avenue, Suite A, Deerfield Beach, FL 33441
- III. The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.
- IV. The maximum authorized capital stock of this corporation shall be One Hundred (100) shares of Common Stock with No Par Value.
- V. The number of directors constituting its initial Board of Directors is one. The name and mailing address is:

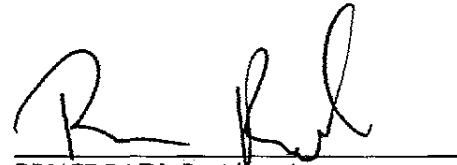
