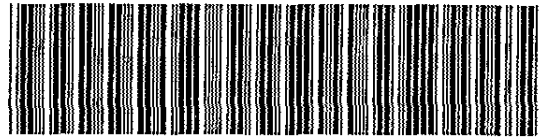

ARTICLES OF INCORPORATION

OF

THE UNDERSIGNED incorporator, TIMOTHY B. WATKINS, an individual authorized to contract, hereby presents these Articles of Incorporation for the purpose of forming a corporation for profit under the provisions of Section 607, Florida Statutes.

ARTICLE I

NAME AND PRINCIPAL OFFICE OF CORPORATION

BOARD OF DIRECTORS

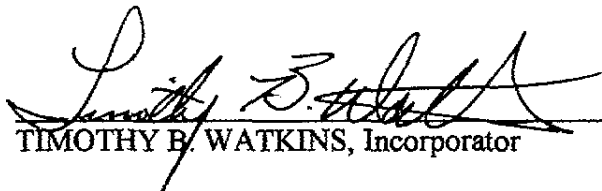

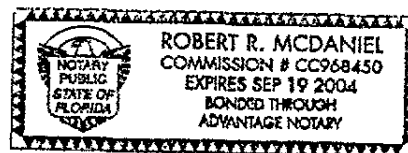

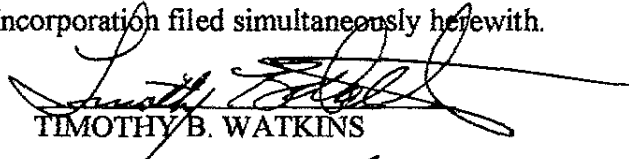
