ARTICLES OF INCORPORATION

OF

JAMES STROH, INC.

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE
NAME

The name of the corporation is JAMES STROH, INC.

ARTICLE TWO
DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE
PURPOSE

The purpose for which the corporation is organized is to provide plumbing contractor services for profit.

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE FOUR
CAPITAL STOCK

The aggregate number of shares which the corporation has authority to issue is one thousand (1,000), all of which shall be common shares with no par value.

ARTICLE FIVE
PREEMPTIVE RIGHTS GRANTED

Each shareholder of any class of stock of this corporation shall be entitled to full preemptive rights to purchase any unissued stock or treasury shares of the corporation and any securities of the corporation convertible into or carrying the right to subscribe to or acquire shares of any such unissued stock or treasury shares.

ARTICLE SEVEN
REGISTERED OFFICE

ARTICLE EIGHT
DIRECTORS

The board of directors shall consist of one member, James Stroh, 518 Holly Street, S. Daytona, Florida 32119.

ARTICLE NINE
INCORPORATORS

The name and address of the sole incorporator is: James Stroh, 518 Holly Street, S. Daytona, Florida 32119.

ARTICLE TEN
OFFICERS

The sole officer of the corporation shall be James Stroh, 518 Holly Street, S. Daytona, Florida 32119, who shall serve as President/Treasurer.

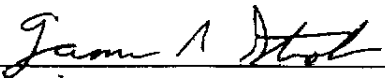
ARTICLE ELEVEN

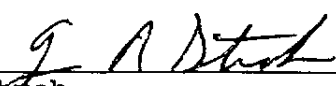
