OF

The undersigned Incorporator subscribing to these Articles of Incorporation, being competent to contract, hereby forms a Florida professional service corporation under the laws of the State of Florida.

ARTICLE I

These Articles of Incorporation may be amended in the manner provided by law.

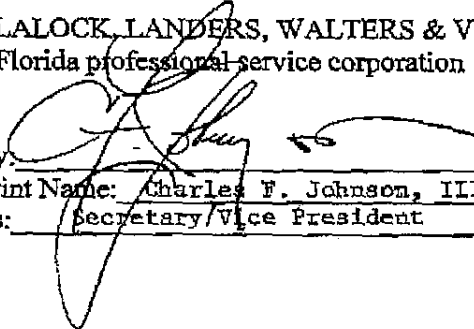
ARTICLE VIII
