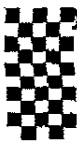

**ARTICLES OF INCORPORATION
OF
PEDIATRIC INFECTIOUS DISEASE ASSOCIATES OF TAMPA BAY, P.A.**

The undersigned files with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a professional service corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of this professional service corporation shall be:

PEDIATRIC INFECTIOUS DISEASE ASSOCIATES OF TAMPA BAY, P.A.

ARTICLE II

Address

The address of the principal office and the mailing address of this professional service corporation shall be 4 Columbia Drive, Suite 820, Tampa, Florida 33606.

ARTICLE III

Purposes

The general nature of the business to be transacted by this professional service corporation or the purposes of the professional service corporation shall be as follows: (a) to engage solely and specifically in the business of carrying on the general practice of pediatric medicine; (b) to invest in real estate, mortgages, stocks, bonds or any other type of investments; (c) to own real and personal property necessary for the rendering of the above professional services; and (d) in general, to have and exercise all powers conferred by the laws of Florida upon professional service corporations, and to do any and all things set forth above to the same extent as a natural person might or could do.

The professional service corporation may engage in the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE IV

Capital Stock

The total number of shares of capital stock authorized to be issued by the professional service corporation shall be 10,000 shares having a par value of \$.01 per share. Each of the said shares of stock shall entitle the holder to one (1) vote at any meeting of the stockholders. All or any part of said capital stock may be paid for in cash, in property or in labor or services actually performed for the professional service corporation and valued at a fair valuation to be fixed by the Board of Directors at a meeting called for such purpose. All stock when issued shall be paid for and shall be nonassessable.

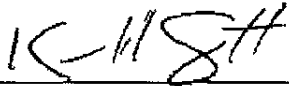
ARTICLE VI

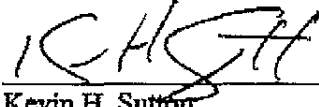
