#### ARTICLES OF INCORPORATION OF:

The undersigned subscriber to these Articles of Incorporation is a Natural Person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

#### ARTICLE I - NAME

## ARTICLE VII AMENDMENT

These articles of Incorporation may be amended in the manner provided by law. ## ARTICLE IX POWER OF CORPORATION
