## ARTICLES OF INCORPORATION GRANT DRYWALL, INC.

SEGRES AND A STATE TALLAHASSEE, FLORIDA

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of incorporation:
