
ARTICLE VII

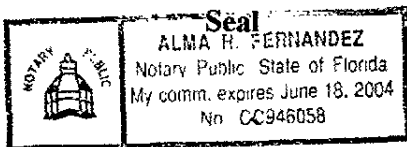


