

ARTICLES OF INCORPORATION OF MOUNTAIN VALLEY RECYCLING, INC.


ARTICLE I- MOUNTAIN VALLEY RECYCLING, INC.

The name of this corporation, formed under the provisions of Section 6 Statues, is **MOUNTAIN VALLEY RECYCLING, INC.**
