THE UNDERSIGNED INCORPORATOR, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. CORPORATE NAME.

The name of this corporation is JKG REBAR, INC.

ARTICLE II. PRINCIPAL OFFICE.

The principal place of business and mailing address of this corporation shall be 24 Old Macon Drive, Ormond Beach, Florida 32174.

ARTICLE III. NATURE OF BUSINESS AND POWERS.
