The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

# ARTICLE I. NAME

The name of the corporation is Dental Temps Professional Services, Inc.

#### ARTICLE II. CORPORATE ADDRESSES
