**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF

Pursuant to Section 607.1006 of the Florida Statutes, the Articles of Incorporation of HEDDEN ENTERPRISES, INC, a Florida corporation (the "Corporation"), are hereby amended as follows:

1. The name of the Corporation is HEDDEN ENTERPRISES, INC. The document number is P03000118804.

2. Article I of the Articles of Incorporation of the Corporation is hereby amended to read as follows:

"ARTICLE V

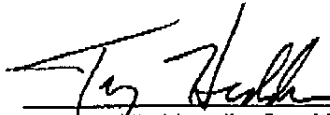

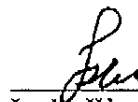
