

ARTICLES OF INCORPORATION

ARTICLE I - NAME

SECRETARY OF STATE TALLAHASSEE. FLORIDA

The name of this corporation is PSS Enterprises, Inc.

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: 250 7th Avenue, South Naples, Florida 341022

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK -
