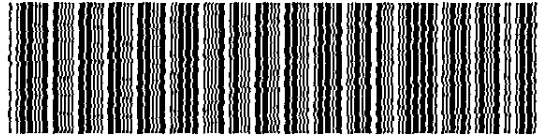

The name of this corporation is **SUNBELT CUSTOM PAINTING, INC.**

**ARTICLE II--PRINCIPAL OFFICE**


