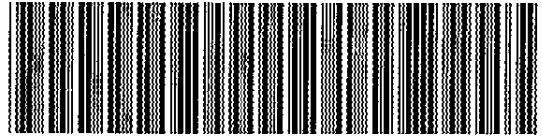

**ARTICLES OF INCORPORATION

The duration of the corporation shall be perpetual.
