ARTICLES OF AMENDMENT TO THE 05 JUN 27 AM 11: 31
 ARTICLES OF INCORPORATION OF

Pursuant to the Florida Business Corporation Act, the Articles of Incorporation of SCOTIA CAPITAL MANAGEMENT SERVICES, INC., originally filed with the Secretary of State of the State of Florida on October 24, 2003, under Document Number P03000119256, hereinafter referred to as the "Corporation", are hereby amended as follows:

1. Article I of the Articles of Incorporation is hereby deleted in its entirety and replaced with the following:

**"ARTICLE I
 NAME**

In accordance with Section 607.0123(1)(b) of the Florida Business Corporation Act, these Amendments shall be effective upon its filing with the Florida Department of State.
