ARTICLES OF INCORPORATION 03 0CT 24 PM 2: 10 OF SECRETARY OF STATE FLORIDA OPHTHALMIC DIAGNOSTICS, INC. TALLAHASSEE. FLORIDA

ARTICLE I - NAME

The name of this corporation is **FLORIDA OPHTHALMIC DIAGNOSTICS**, **INC.** located at 240 Charles Court, Satellite Beach, FL 32937.

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing upon the filing of these Articles of Incorporation by the Department of State.

<u>ARTICLE III - PURPOSE</u>
