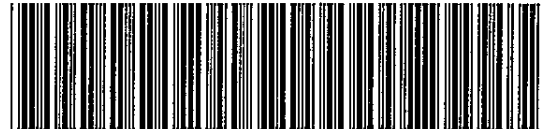

ARTICLE I - NAME

The name of this corporation shall be:

George R. Kimbrell, DDS, PA

ARTICLE II - NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation. The specific nature of the business is Dentistry.

ARTICLE III - DURATION

This corporation shall have perpetual existence.

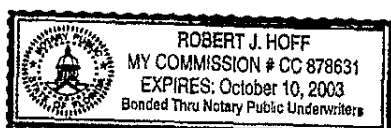
