


#### ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is <u>THE CORTES LAW GROUP, P.A.</u> and its principal place of business shall be located at 3501 W. Vine Street, Suite 280, Kissimmee, FL 34741.

#### **ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

#### ARTICLE III - PURPOSE

This professional service corporation is organized for the purpose of transacting any or all lawful business including, but not limited, to engage in every aspect of the practice of law, and all the fields of specialization as are engaged by lawyers.
