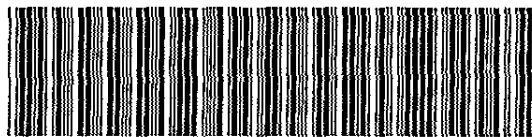



ARTICLE I. NAME

The name of this corporation is
JOE'S CERAMIC TILE, INC.

ARTICLE II. DURATION

This corporation shall have commence January 1, 2004,
and shall have perpetual existence.



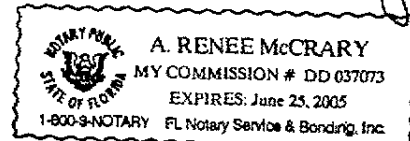
